# **Commercial Connections in the Community**

**Base Rate:** \$25.00/month

Flow Rate: \$5.75 per 1,000 gallons

Unoccupied residences with an active service that are connected to the District <u>water system</u> shall be charged a flat fee of \$30.00/month.

\*\*\* All customers receiving water service will be assessed a Water Conservation Surcharge in the amount of \$5.00 per 1,000 gallons over 12,000 gallons while in Stage 3, a surcharge of \$10.00 per 1,000 gallons over 10,000 gallons while in Stage 4, and a \$20.00 surcharge per 1,000 over 8,000 while in Stage 5 of the Water Conservation Plan.\*\*\*

\*\*\*As of June 13, 2022, Flying L PUD is in Stage 5 of the Water Conservation Plan\*\*\*

In addition to the foregoing rates, the consumer shall pay any taxes or assessment imposed thereon by law.

## \*SEWER\* SERVICE RATES

Rates below are for Residential Sewer Connections and Commercial Sewer Connections.

#### **Residential Connections**

**Base Rate:** \$22.50/month

# **Commercial Connections**

Base Rate: \$18.50/month

Flow Rate: \$6.50 per 1,000 gallons

Unoccupied residences with active service that are connected to the District <u>sewer system</u> shall be charged a flat fee of \$22.50/month.

In addition to the foregoing rates the consumer shall pay any taxes or assessments imposed thereon by law.

## \*OTHER\* RATES & FEES

Rates and Fees below are for Commercial Grease Traps, Garbage (dumpster usage), Generator Assessment, New Customer Set-Up, Vacate Easement and Pool Inspections.

**Commercial Grease Trap** 

**Inspection Fee:** \$50.00/month per each grease trap installed

Garbage Rate \$20.00/month

**Generator Assessment** 

**Residential Connection:** \$10.00/month

**Commercial Connections:** \$10.00 per unit/month

**New Customer Set-Up** 

**Meter Connection Fee:** \$50.00 (one time)

**New Service Deposit:** \$350.00 (refundable all *or* in part depending on payment of final bill)

New Meter Tap Fee: \$4,350.00 (one time) New Sewer Tap Fee: \$4,350.00 (one time)

**Customer Service Inspection Fee:** \$75.00

**Vacate Easement Fee** \$30.00 (each occurrence)

# Swimming Pool and Hot Tub Inspections and Fee

Every user who plans to construct or install a swimming pool, spa, or hot tub (collectively, "Pool") within the District shall notify the District operator in writing prior to commencing construction of the Pool.

Once notification by the user of the intention to construct or install a Pool, a single-family residential user shall pay an **Inspection Fee of \$125.00**.

## \*LATE\* FEE

10% of your billed amount will be assessed if your bill is not paid by the Due Date.
